20/35 Minutes of the previous Meetings

Minutes of the Bradley Parish Council Meeting held on Thursday 23rd July 2020 and the AGM held on the same date, were agreed and signed by Chair.

Suspension of Meeting by Chair for Public Forum (Time 19:01)

A resident raised concerns about the number of matches being played at the Bradley Football Complex with little or no regard to the current Covid 19 restrictions and the large amount of vehicles parking on the verge way. (Time 19:09)

20/36 Police Matters

There was no police report due to the change of date for the meeting. Chair reported that she has been in regular contact via email with the local for Bradley regarding the motorbike activity. Activity has eased over the last few weeks, and 101 reports appear to have been acted upon much quicker, it is hoped that the CCTV cameras are proving to be a deterrent.

20/37 Planning Matters

It was agreed by Council that a request for Manor Farm Mews to be included in the 20mph speed limit which is currently in force on Church Lane, would be made to NELC.

It was reported that Planning Application DM/0056/20FUL (82 dwellings to be erected at Barnoldby le Beck near Bradley Road) was on the Agenda for the next Planning Committee (04-11-2020), and BPC would check the website for the outcome and report at the next Bradley Parish Council meeting.

A resident had reported to the Chair that construction had been started on a road giving access off Bradley Road to Woodlands Poultry Farm. This has been reported to NELC who are in the process of investigating it.

Activity at Shepherds Purse was discussed at great length and ideas were raised in what to do next and when they should be acted upon.

A plan is now in place by the Highways Department, to address the issue of verge parking along Bradley Road. They will be contacting BPC in the next few weeks and consequently the residents of Bradley who are affected, for comment.

20/38 Finance

Clerks wages were paid, receipt for cartridges was handed in to the RFO for refund next month. A contribution was made to St Michaels Church for its use as a venue. The Vision ICT invoice was also paid for the upkeep of BPC website.

Cllr Poppleton asked the council members to consider the precept before the next meeting.

20/39 Clerks Update

Clerk reported that the top of Church Lane where it meets Bradley Road, will be included by the NELC salt gritters when Bradley Road is serviced. The salt bin will also be restocked as and when required.

A request for Church Lane to be cleared of leaves and debris was made to NELC and this has been completed.

An online presentation will take place regarding the latest information about the new recycling system which the clerk will attend and report on.

20/40 Information Exchange

With regard to the CCTV and the payment, it was agreed by all Councillors that due to the current climate, footage taken from the cameras, (showing where they are positioned), could be downloaded to BPC – from Engie instead of Engie providing a demonstration in person. Then providing they are satisfactory the account can be settled.

Chair reported that she had contacted the wardens for St Georges Church, Bradley, with the suggestion that they consider applying for funding to install water and plumbing for a toilet at the church and possibly heating, at a later date. This will be discussed at their next Church meeting.

Chair asked all Council members to consider the possibility of holding all future council meetings at St Michaels Church when the current climate allows., it was agreed for Chair to make further enquiries.

A resident had suggested to Chair the idea of a map being placed at the top of Church Lane displaying where the properties are, with their names on. This was due to the fact that very few properties have numbers (just names) and delivery drivers in particular, struggle to locate them and need to ask local residents. This was voted upon and was not agreed unanimously so will not be pursued.

Cllr Poppleton raised the issue about a bridle way being closed without informing Bradley Parish Council and it was agreed that BPC would gather more information and contact NELC for information.

20/41 Date of the Next Meeting

The date of the next meeting will be in January 2021, the date and venue to be confirmed.

It was agreed that all council members will look into how to create and run a virtual meeting, incase the next meeting cannot be taken in person.
