21/04 Minutes of the previous Meetings

Minutes of the Bi-monthly Meeting held on Tuesday 3rd November 2020 were agreed and signed by Chair.

21/05 Finance

It was agreed that BPC would request a partial refund of the annual amount of £100.00 paid in advance to Bradley Football Complex when only 2 meetings were able to be held due to Covid 19 restrictions. Payment for the CCTV cameras would be sent once footage of the cameras viewings was seen and confirmed as correct. Engie have confirmed that this footage will be submitted next week. It was agreed that the training course for the Clerk regarding Year End Accounts would be paid.

21/06 Precept

The Financial Officer had provided all Councillors with a copy of the precept workings prior to the meeting and all Councillors agreed with it being signed off. ERNLLCA membership was discussed at length and it was agreed that an email would be sent regarding the level of service being received, to justify the membership fee. It was also agreed that further investigation would take place before March 2021 to decide if St Georges Church required two brown bins per year.

Chair reported that the local Police Officer for Bradley is in regular contact with updates and information and it appears that the issues with the motorbikes has calmed down for now. Council members confirmed this to be correct.
