#### **22/04 Minutes of the previous Meeting**

Minutes of the Bradley Parish Council Bi-monthly meeting held on 4<sup>th</sup> November 2021 were agreed and signed by the Chair.

Cllr D Hasthorpe reported that the Planning Application No DM/0744/21/FUL had been approved with conditions by NELC Planning Committee.

### **22/05 Police Matters**

Chair read out the Police Report and there were 4 crimes in Bradley for November and December. The two in November were an electric cycle stolen and a Security Guard was abused by three males on bikes before riding off. Two in December were an assault at the hospital and dog walkers being abused and knocked over by a group of youths on motorbikes at Bradley Woods.

A meeting was arranged between NELC Footpaths and Bridleways and a Community Officer at Bradley Woods to discuss the access to the woods and the state of the public pathways. The Community Officer was unable to attend and an email was sent to BPC from NELC.

### **22/06 Planning Matters**

Planning Application No DM/1228/21/FUL was sent to councillors and there were no objections to the application.

### **22/07 Precept**

The precept was discussed at great length and some alterations were made and agreed. RFO will send out the revised version to all Councillors.

### **22/08 Online Banking**

Confirmation of the changes made to the signatories for cheques has still not been received and will be followed up this week. Once this has been confirmed, online banking will be applied for.

### **22/09 Finance**

The clerks wages were paid and a donation to the church was made for the use of the Church.

The age of BPC's laptop was discussed and it was agreed that a new one should be purchased. All councillors would research the cost, specifications and brands prior to the next meeting.

The need for a further filing cabinet for BPC paperwork was discussed at it was agreed that prices would be researched by the Clerk.

### **22/10 Emergency Plan Review & Update**

The changes made to the Emergency Plan were discussed and an updated copy has been sent to NELC and Humber Emergency Planning Service for their records. A copy will be sent to all members of the Council next week.

### **22/11 Clerks Report**

The Clerk reported that the response from the new Newsletter appears to be positive and the new parking regulations on Bradley Road and Church Lane also appears to be working.

### **22/12 Update on Ongoing Issues**

The Chair continued to report that Bradley Football Complex have relined their car park which has improved the amount of cars able to park in the centre. There was an incident where numerous vehicles were parked on the verges due to the gates being locked, this was reported to Highways Enforcement who dealt with it accordingly.

The street light being blocked by overhanging branches that was reported at the last meeting has been followed up and will not be dealt with by the council as the tree is on private property. Chair has spoken to the owner and they have agreed to cut the branches.

St Michaels Church has been booked for the year ahead to correspond with BPC bi-monthly meetings and all Councillors have been informed of the dates.

### **22/13 Information Exchange**

The applications for joining Bradley Parish Council were discussed at length.

### **22/14 Date of Next Meeting**

The date and venue for the next Bradley Parish Council Meeting will be on Thursday 3<sup>rd</sup> March 2022, subject to Covid 19 updates.
