#### 22/18 Minutes of the previous Meeting

Minutes of the Bradley Parish Council Bi-monthly meeting held on 6<sup>th</sup> January 2022 were agreed and signed by the Chair.

#### Suspension of Meeting by Chair for Public Forum

The meeting was not suspended due to there being no members of the public being present.

#### 22/19 Police Matters

The police report was read out by Chair and there were two incidents reported in January and February, both being at the Bradley Complex Centre. There was one report of motorbikes being ridden illegally. Chair pointed out that she had made three reports herself and this would be looked into next week.

#### 22/20 Planning Matters

Planning Application No DM/0036/22/FUL (installation of post construction on field drainage to support the operation of the Hornsea Project Two Offshore Wind Farm) was sent to councillors and there were no objections to the application.

#### 22/21 Co-option

There has been some interest shown for the vacancies on Bradley Parish Council. It was agreed that all interested parties would be sent an official application form provided by ERNLLCA to be completed within the return date. This matter will then by concluded at the bi-monthly meeting in May.

#### 22/22 Finance

The clerks wages were paid and a donation to the church was made for the use of the Church.

It was agreed that BPC for 2022, will pay for one brown bin for the Church because after monitoring the previous year usage, two bins are not required. The invoice from NELC for the bin charge has been passed to the RFO. The invoice for the laptop purchased for BPC was given to the RFO.

BPC have been informed that there will be a rise in costs for the Website Maintenance from Vision ICT.

Although acceptance of the CCTV Maintenance Contract was sent to the relevant party, no official contract has yet been received.

#### 22/23 Update on Ongoing Issues

A request for Online Banking has been completed but due to a query with the emails on file at the bank, a new application has been requested by Nat West. The Facebook group for Bradley Parish Council has been launched and will be featured in the next Newsletter which is ready to be delivered.

The research for the new computer has been completed and discussed with all Councillors prior to purchase. Various forms of Security Systems were discussed and Word Operating systems. These will be looked into before the next meeting.a

Filing cabinets have been researched and it was agreed to purchase one from Argos.

The RFO has agreed to send the revised version of the Precept out to Councillors. The RFO has also agreed to check through the new version of the Emergency Plan placed on the BPC website.

#### 22/24 Information Exchange

It was agreed that the back up of the computer files onto the external drive will be done again this week.

An email had been received from Ward Cllr Hasthorpe relating to the ConnectNEL scheme asking councils to feature it in their Newsletters. The clerk rang Centre4 and leaflets were delivered to Chair to be included with the Newsletter.

Cllr Bryden mentioned the parking on the verges along Bradley Road had been reduced significantly but not stopped. Chair will send the direct number for Parking Enforcement to Cllr Bryden to report as necessary.

It was felt that the first no parking on the verges sign placed at the entrance to Church Lane leading from Bradley Road was not very obvious or noticeable, and so it was agreed that BPC will contact highways about this.

Comments were made about the number of properties that have gone up for sale along Bradley Road recently.
