24/04 Minutes of the previous Meeting

Minutes of the Bi-monthly Meeting held by Bradley Parish Council on 9th Neovmber 2023 and the Extra Ordinary Meeting held on 14th December 2023 were agreed by all councillors present at that meeting and signed by Chair.

24/05 Police Matters

The Police Report was read out by Chair and it was noted that there was one theft of some fencing being stolen on Bradley Road and four assaults at the Complex Hospital. There were no ASB reported although motorbike disturbances had been reported.

Members of the public had nothing to discuss within the suspension, but it was agreed that because there was a presentation to follow this section, including a question and answers section, members of the public could speak then.

24/06 Planning Matters

With regards to planning application DM/1037/23FUL – Woodlands Farm, Bradley there were no objections.

With regards to planning application DM/1156/23/FUL – proposed solar farm on Bradley Road, the representative from the Company, proceeded to give a very detailed presentation of the proposal and provided all those present with a brochure containing photographs and information. The floor was then opened for Questions and various members of the public asked various questions that all appeared to be answered sufficiently.

24/07 Precept

After a brief discussion over the assets that are included in the precept, all councillors present agreed unanimously that the draft figures proposed by the RFO, could be submitted to NELC.

24/08 Finance

There was nothing to report in Finance and no questions were asked by Councillors.

24/09 Update on Ongoing Issues

The information that was requested by Stagecoach and EQUANS has been sent by BPC and we are waiting for a response from them for updates.

The incident with the fencing that protruded from the ground at Bradley Ponds has been rectified.

The Emergency Plan overhaul is still in progress and it was agreed that a Whatsapp group would be set up for Councillors to contact each other in the event of an Emergency and GDPR forms would be provided for residents to complete if they would like to be contacted directly by BPC if an emergency were to occur. They will be available from the Surgery Events and future Bi-monthly Meetings.

A request has been sent for a further speed bump test, and the response was to try some more speed repeaters along Church Lane for a period of time, and if they don't work, to contact highways dept again.

A request for a safety check on the trees in Bradley was submitted to NELC and we were informed that one had been completed in May 2023. After more concerns were raised about the safety of some of the larger, privately owned trees, it was agreed that BPC will contact NELC again for advice on the best way to contact these residents.

24/10 Information Exchange

It was agreed that BPC could purchase some cartridges for the Clerks home printer as a substantial amount of printing is done from her home. An idea of purchasing a sandwich board to advertise the surgery date/times was denied. The use of the notice board outside St Georges Church was queried and it was agreed that BPC would look at its' condition and see if we are able to provide some basic information for it now covid restrictions are lifted.

24/11 Date of Next Meeting

The date and venue for the next Bradley Parish Council Meeting will be on Thursday 7th March 2024, at St Michaels Church, Great Coates Road.
