#### **25-15 Apologies**

Apologies were received by Cllr D Bryden

#### **25-16 Declaration of Interest (Local Government Act 2012)**

There were no declarations of Interest.

#### **25-17 Minutes of the previous Meeting**

Minutes of the Bradley Parish Council's Bi-monthly meeting held on 16<sup>th</sup> January 2025, were previously sent to all Councillors in draft form. These minutes were all agreed by those that were present at that meeting to be correct, and were signed by Cllr Poppleton who chaired this meeting.

### **25-18 Co-option of New Council Members**

Cllr Swallow had completed all the paperwork at the start of the meeting and was officially co-opted on to the council and welcomed once again by all council members.

### **25-19 Police Matters**

A copy of the Police report was handed out to all councillors and it was noted that once again, the Bradley Complex Centre appears to create the most reports.

### **25-20 Planning Matters**

Planning Application No DM/0103/25/FULA relating to a property in Manor Farm Mews was discussed and it was agreed that Bradley Parish Council had no objections. The clerk will inform NELC.

There was no update on Enforcement No EN/1086/24 relating to Bradley Ponds.

### **Suspension of Meeting by Chair for Public Forum**

No members of the public were present and Ward Cllr Hasthorpe had no comments to make so the meeting was not suspended.

### **25-21 Finance**

The RFO reported that the clerks wages and the hire of the church had been paid. Standing orders were all proceeding as previously agreed. The brown bin for the Church would continue to be paid for once the request for payment comes from NELC. This was agreed upon unanimously. Stamps, the printed Electoral Role and an empty lever arch file were handed to the clerk by the RFO. The clerk requested a ream of paper for printing purposes, which was agreed unanimously by all council members.

### **25-22 Emergency Plan Review**

The Clerk had previously distributed via email, copies of the current EP and indicated where changes were to be made. She also distributed a breakdown of where each EP member would cover in the event of an emergency and this covered each property and business within the village. Cllr Swallow volunteered to be the lead if there was an emergency and all council members present agreed unanimously. He has also offered to redesign the plan and will send the revised version to council members for their comments in the coming weeks.

### **25-23 Update on Ongoing Issues**

Cllr Swallow is in the process of organising a suitable place for the convex mirror to be situated and will update council members at the next meeting. We have heard nothing about the solar farm that was proposed for Bradley Road so the clerk will contact them for an update on the funding that was offered to BPC. The photographic images from the CCTV cameras in the village have still not been received and the clerk reported that she had been in contact with NELC for an update. There has been no further information regarding the proposed project for the open space opposite the football grounds.

### **25-24 Information Exchange**

The microsoft office subscription is due for renewal and will be increased from £59.99 to £84.99 per year. It was agreed that alternative word processing packages would be looked into and all council members agreed to cancel the existing subscription. Clerk will do this prior to the payment being due.

### **25-25 Date of Next Meeting**

The date for the next Bradley Parish Council Meeting will be 1<sup>st</sup> May 2025 and will include the AGM. The venue and time will be same.
