### **2026-09 Chairman's Report**

The Chair reported that after his first full year in the role there had been nothing dramatic to report. A new convex mirror to aid vehicles entering and leaving Manor Farm Mews has been approved and purchased and we are currently waiting for the installation to be completed. The poppies had been displayed again and this will continue to be completed annually. Discussions had taken place for a planter for the village and currently Bradley Parish Council are applying for quotes to replace the notice board outside of St Georges Church. There have been no major planning applications reported and at the time of this meeting the only outstanding application relates to land adjacent to Bradley Woodlands Independent Hospital.
