A Planning application DM/1027/18/FUL for a further development at Scartho Top had been received by BPC who replied stating no objections at this stage.

The Financial Officer provided Council with a copy of Bradley Parish Council's Precept Workings and it was agreed that the Precept for 2019/20 be set at a total of £2623, with a possible addition of £77.00 funding from NELC, to be concluded, making a total of £2700.00.
