19/45 Minutes of the previous Meetings

Minutes of the AGM and Bi-monthly Meeting held on Thursday 9th May 2019 and the Extra-Ordinary Meetings held on Thursday 27th June 2019 were agreed and signed by Chair.

Suspension of Meeting by Chair for Public Forum (Time 19:03)

A Member of the public voiced concerns once again about the motorbikes that are being ridden through the village and across fields at great speed and without due care or attention. As this is an issue throughout the town it was agreed that the matter would be raised at the next Town and Parish Meeting. It was also suggested that an official letter should be written to the Commissioner again.

19/46 Police Matters

It was agreed that an email would be sent to the Police Department regarding the lack of a Police report for the Bradley Area. A Police Engagement Officer named Katrina Goodhand has been in touch about attending the next meeting as she was unable to make this one.

19/47 Planning Matters

It was discussed and agreed that all responses to the Planning Department from Bradley Parish Council would be put on the website and the notice board, as well as being sent to the Councillors. This will start as soon as the website has been altered to accept this facility.

Poultry Farm A further update was given on the Poultry Farm Planning Application. Councillors agreed that the response to the original planning application for change of use on this site was satisfactory and complete. Therefore any further communication is received by BPC it will be dealt with accordingly.

Bradley Ponds A further update was given on the Bradley Lakes Planning Application.

Chair reported she had spoken to planning and agreed with them to contact the site owner of Bradley Lakes to discuss further details needed although it was felt that this above negotiation really should be conducted by the planning department but getting it sorted was the priority. Everyone agreed it was a worthwhile project.

19/48 Finance

Stationery receipts were presented and a cheque was written for reimbursement, along with a cheque for Computer Training. After much discussion it was agreed that a Debit Card for the Bradley Parish Council would be applied for and issued to the Chair and the Financial Officer. This was proposed by Cllr Andrew Poppleton and seconded by Cllr David Bryden and the vote was unanimous. It was decided that there would be a limit of £100 usage per day and all transactions would be recorded for the Finance Officer.

19/49 Information Exchange

Chair contacted Highways Department for update on verge parking etc and was told no conclusions yet but it still is under discussion.

Council were contacted re NELC Skip – it Project and whilst BPC were keen for the system to be introduced again as NLC appeared to be asking for volunteer from each council to be responsible for the running of the service it was decided this project was not right for BPC.

NELC waste bin department were contacted with regard to the request for the extra bin to be placed on the fork of Church Lane and the Bridleway. NELC responded saying the bin would be put in place when all the other bins had been replaced.

Chair reported no further communication re CCTV from Engie Officer.
Cllr Turner suggested the possibility of obtaining quotes from private companies although this could create difficulty in connecting to NELC street light power.
