It was agreed that Bradley Parish Council will complete the waste disposal survey on behalf of residents but residents are welcome to complete this themselves as members of the public.

With regard to the CCTV the recent quote was discussed at length and it was agreed that the installation could go ahead. This was proposed by Cllr Poppleton and seconded by Cllr B Turner.
