"relevant person": means M or any other person referred to in section 30(3) of the Act;

"securities": means shares, debentures, debenture stock, loan stock, borunits of a collective investment scheme within the meaning of the Finance Services and Markets Act 2000 and other securities of any description, other the money deposited with a building society.
