"M": means a member of a relevant authority;

"member": includes a co-opted member;

"relevant authority": means the authority of which M is a member;

"relevant period": means the period of 12 months ending with the day on which M gives a notification for the purposes of section 30(1) or section 31 (7), as the case may be, of the Act;

"relevant person": means M or any other person referred to in section 30(3)(b) of the Act;

"securities": means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
